**Tagesordnungspunkt:**

**Teilnahme des Rhein-Kreises Neuss am European Economic Congress 2009 in Kattowitz**

**Sachverhalt:**

Der Rhein-Kreis Neuss als bedeutender Energiestandort war beim UN-Klimagipfel in Posen vertreten. Dort sind von Herrn Nordmann vom Amt für Entwicklungs- und Landschaftsplanung in Vertretung des Landrates auch vorbereitende Gespräche für die in der Nachfolge stattfindende Konferenz in Kattowitz, in die die Themen und Inhalte der deutsch-polnischen Energiekonferenz eingebettet werden, u. a. mit Bundesumweltminister Sigmar Gabriel, geführt worden.

Mit Schreiben vom 09.01.2009 hat jetzt der Veranstalter des European Economic Congress 2009 (EEC 2009), die große polnische Mediengruppe PTWP, Landrat Dieter Patt eingeladen, für den Rhein-Kreis Neuss und seine Partner den lokalen Energiepakt vorzustellen (s. Anlage). Auch der Kreis Mikołow wird mit Landrat Henryk Jaroszek beim EEC 2009 vertreten sein.

**Der EEC 2009:**

Der European Economic Congress 2009 (EEC) ist einer der größten Wirtschaftskonkresse im Jahr 2009 in Osteuropa. Es werden mehr als 2.000 Teilnehmer in Kattowitz erwartet.

Auslöser für den Kongress ist die Tatsache, dass Europa sich in großen, politischen und wirtschaftlichen Herausforderungen gegenüber sieht. Die politischen Entscheidungen der

Europäischen Union haben große Auswirkungen auf die Wirtschaftlichkeit aber auch auf eine nachhaltige Entwicklung.

Eine beständige und verantwortungsvolle Wirtschaftspolitik muss heute einerseits auch die Belange der Umwelt und den Erhalt des natürlichen Erbes für zukünftige Generationen beachten. Andererseits haben die EU-Vorgaben zum Klimaschutz – insbesondere die Reduktionsziele für CO 2-Emissionen – weitreichende und zum Teil langfristige Auswirkungen auf die Wirtschaft der EU-Mitgliedsstaaten und deren Wettbewerbsfähigkeit.

Umweltfreundliche Vorgaben haben zum Teil ernste Auswirkungen auf energieintensive Industrien und auf die natürliche Umwelt. Insbesondere die neuen EU-Mitgliedsstaaten haben noch immer mit den Schwierigkeiten der Vergangenheit zu kämpfen.

Die heutigen Rahmenbedingungen veranlassen viele Unternehmer dazu, ihre Produktion in die sich schnell entwickelnden Ländern Asiens oder der Dritten Welt zu verlagern. Die Wirtschaften der europäischen Länder müssen ihren bisherigen Vorteil durch die Entwicklung von Innovation und wissensbasierte Technologien sowie vermehrte Zusammenarbeit zwischen Wissenschaft und Wirtschaft erhalten und ausbauen.

Mit diesen grundlegenden Veränderungen konfrontiert, kommt dem Dialog heutzutage besondere Bedeutung zu. Es muss darüber diskutiert werden, wie die Staaten der europäischen Union sich diesen Veränderungsprozessen stellen und welche Qualitäten gefördert werden müssen, um im Wettbewerb mit den dynamischen Ländern Asiens und der neuen Welt mitzuhalten. Kürzlich hat die Weltwirtschaftskrise sowohl Europa als auch insbesondere Polen erreicht und bereits zu ernsten Auswirkungen in manchen Branchen geführt. Die Unternehmen, Regionen und Länder sind gezwungen ihre Strategie an die neue Situation anzupassen. In diesem Zusammenhang ist eine gemeinsame Debatte über unsere Schwächen und Stärken und unseren Platz in der Weltwirtschaft unerlässlich.

Der European Economic Congress soll dazu beitragen eine neue Qualität in den europäischen Dialog zu bringen.

#### **Programm:**

Aus dem beigefügten Programmentwurf sowie der Gästeliste ist ersichtlich, dass der EEC ein hohes Maß an Aufmerksamkeit in Politik, Wirtschaft und Medien hat und hochkarätig besetzt ist.

Diskutiert werden hier u. a. die Auswirkungen der Weltfinanzkrise sowie die Vorgaben der europäischen Union zur Energiepolitik und deren Auswirkung auf die Großindustrie.

Donnerstag, 16.04.2009 In verschiedenen thematischen Diskussionsforen werden aktuelle Themen aus Gesellschaft, Wirtschaft und Politik erörtert.

Im Diskussionsforum „Innovation für den Klimaschutz“ wird Herr Prof. Harald Bolt vom Forschungszentrum Jülich über aktuelle Beiträge aus unserer Region referieren. **Idea**

Europe is facing a great political and economic challenge. The political decisions of European Union members defined the way the economy is to be developing on our continent. Community of European countries has decided that striving for competitiveness and efficiency it will take into account the environment needs respecting at the same time the principles of sustainable development.

Consistent and responsible economic policy taking into consideration the interest of the environment, results in, on the one hand, improvement of standard of living and the natural heritage is being preserved for the future generations. On the other hand all accepted restrictions and ambitious requirements strictly connected with climate package – above all with reduction of CO<sub>2</sub> emissions by the industry or bigger share of renewable energy – bring about far-reaching, permanent and almost immediate effects for the economies of the member states, their effectiveness and global competitiveness.

Environment-friendly regulations have particularly serious impact on energy-intensive industries and deeply affect the natural environment. New member states of EU have been subjected to particularly strong pressure with Poland among others. In spite of dynamic transformations of their economies they are still wrestling with their problems of the past. For them, it will be by far more difficult to meet these rigorous settlements than for the developed countries of old European Union.

In this context one may hazard a thesis that the Europeans are in for post-industrial revolution. Noxious to environment and energy-intensive industries will be gradually withdrawn – the manufacturers will transfer their production to fast developing countries of Asia or the Third World among others. The economies of European countries will have to build up their advantage through the development of innovations and the economy based on knowledge – the use of state-of-the-art technologies, interaction of business and science.

Confronted with these imminent transformations a dialog becomes of particular importance. It has to be discussed how the countries of European Union will go through this new transformation and what chief assets might be applied by them to compete with economically dynamic countries of Asia or the New World.

Recently, the echoes of the world's crisis reach both Europe and Poland, and its severe consequences have already been felt by some branches. The firms, regions, and countries are faced with the necessity to adopt their strategies to the new situation, to re-orient their vision of development. In this context, a joint debate on our strong and weak sides, on our place in the world's economics becomes particularly and urgently needed.

We believe that Poland is a good place for such debates – as it is one of the fastest developing countries in Europe. Hence Upper Silesia constitutes a splendid framework for such debate in Poland. It is a region with one of the biggest agglomerations of our continent, an area of a great potential and rich industrial traditions, which effectively modernizes and transforms its economy – however it is still dependent on traditional sources of energy and enters into complex interactions with natural and social environment.

We can easily hazard a thesis that it is here in Silesia that the economic issues and challenges as well as social ones of the united Europe concentrate.

Referring to the idea of Robert Schumann who thought that "The value of Europe is Europe of values" one can dedicate to the economy of the Old Continent the following watchword: „The Greatness of Europe is the Europe of Greatness" In order to make this greatness come true a concrete dialogue and trustworthy co-operation is necessary – after all, we know that we can, as a community, do more together than just alone.

The organizers of European Economic Congress would like to contribute a new quality to this dialogue. This three-day meeting of two thousand most important people for the European economy are bound to create a precious value – this will make it possible for us all to be more aware and with joint forces cope with the challenges of today's world.
